Grobe compressor station was close to the pipeline and gas was routed here rather than a temporary flare.
Steps taken to limit the duration and magnitude of vent or flare	The 16" steel pipeline was blown down to the Grobe Compressor Station flare as expeditiously as possible to protect personnel and equipment.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	The pipeline was blown down for the safety of personnel and equipment at the Grobe Compressor Station. The pipeline will be replaced and once determined safe to operate, returned to service.
