

The total volume of produced water released from the Lario Area 51 SWD Pipeline North (Incident #NAPP2506655962) is unknown due to the release originating from an underground pipeline. Because it was not discovered until fluid surfaced at ground level, the duration and flow rate of the release remain undetermined. A total of 300 barrels were recovered during initial response efforts. No other volume estimates or calculations are available. This incident occurred on NMSLO Leases VC06480002 and VC04240003, located at Unit P, Section 15, Township 18S, Range 34E (32.74297, -103.539826 NAD83).
