Please explain reason for why this event was beyond this operator's control	Station shut down due to high-high level alarm on condensate tank. During shutdown inlet separator water dumps stuck open causing gas blowby into tanks which resulted in venting.
Steps taken to limit the duration and magnitude of vent or flare	Station was shut in which reduced gas and liquids to tanks. Closed all the dump valves to stop gas blowby which ended venting. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas vented.
