Greetings all,

OCD does not consider the attached to be a sampling plan. In addition, there is a remedial proposal of sorts included in this document. As such, the document is rejected in its entirety. Be advised that App ID 511247, submitted through OCD Online Permitting Portal by Ray Westall Operating has been rejected due to errors made during the submission. A re-submittal is due by November 13, 2025 for review. Also be advised that no fluid or chemicals are to be applied to this release in any form other than natural precipitation events. If fluids and/or chemicals have been applied, OCD requests volumes, types, analyses, dates of application, SDS, and any other pertinent information be submitted to OCD immediately.

It is also noted that the Date of Discovery for this release was listed as being 12/31/2020. Google Earth Imagery Date 12/21/2019 indicates the release occurred prior to the 2019 date. In the event enforcement actions are initiated for this release, the time frame for the release and lack of response will be considered, as well as Ray Westall Operating's cooperation in bringing this incident to a rapid closure going forward. Recycling previously rejected proposals will likely not be conducive to a rapid closure.
