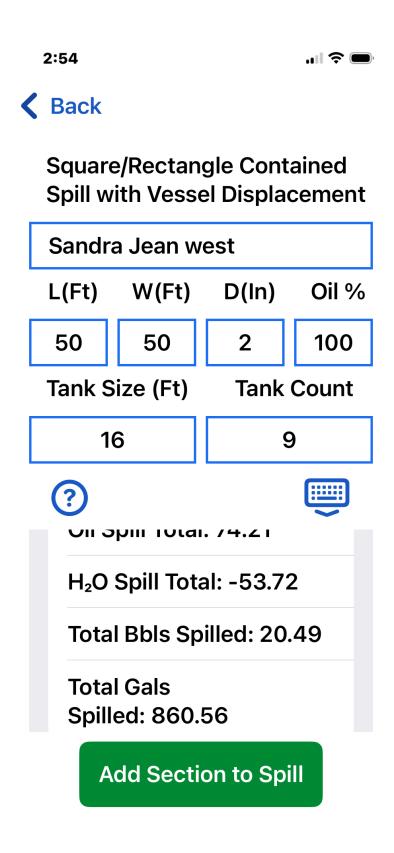

This incident resulted in the release of 20 barrels of crude oil into the lined containment. All fluids remained inside the containment and were recovered with vac trucks. The containment will be washed, and a liner inspection will be scheduled in the coming days.
