Flash fire occurred on engine skid, which is constructed on a concrete foundation. Techs were onsite performing scheduled maintenance on another unit onsite and witnessed event. Fire self-extinguished and unit was immediately taken offline and will remain offline until repairs are completed. No injuries associated with this event. No fluids released onto the ground.
