After isolating the system, it was discovered that the isolated root valves were leaking by, allowing alkylate gasoline to be released, resulting in a fire. The fire was immediately extinguished using fire monitors, and operators began de-pressuring and safely shutting down the unit. There were no injuries and there was no offsite impact.
