Please explain reason for why this event was beyond this operator's control	HY NM Section 10 CTB and Compressor Stations had a power failure due to a storm. The power failure shut down the facility, including the vapor recovery units. Once the storm including lightening stopped, the operator went to the facility and brought vapor recovery units back online.
Steps taken to limit the duration and magnitude of vent or flare	Shut in production at all facilities and focused on getting power back on. Once power was back on, ensured all vapor recovery units are operational before putting production back online. All venting that occurred during the duration of the event was residue gas in the facilities.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas vented. Reportable quantities, process knowledge, excel spreadsheet, and gas analysis were used in the calculations.
