1. Set RBP in 5 1/2" casing at 1,780'.
2. Set Whipstock in 5 1/2" casing at 1,687'.
3. Cut window in 5 1/2" casing at 1,687'.
4. Drill a 4 3/4" hole in a 143' (40°) Radius curve to a 1,600' horizontal lateral in the upper Vermejo coal (Top 1,820').
5. Run 3 1/2" liner (No Cement) the length of the lateral.
6. Retrieve Whipstock and RBP.
7. Clean out wellbore , run production equipment, and put well back on production.


