Yates Petroleum Corporation proposes to drill/test the Yeso and intermediate formations. Approximately 400' of surface casing will be set/cemented to shut off gravel and cavings. If commercial production casing will be run/cemented; will perforate/stimulate as needed for production. MUD PROGRAM: 0-400' - FW Gel/Paper; 400' - 2000' Brine; 2000' - TD Cut Brine. BOPE PROGRAM: A 2000# BOPE will be installed on the 8 5/8" casing and tested daily.
