COG proposes to drill 17-1/2 hole to 425' w/fresh water mud system, wt 8.5, vis 28. Run 13-3/8" csg & cmt. Drill 12-1/4 hole to 1225' w/brine mud system, wt 10, vis 30. Run 8-5/8 csg & cmt. Drill 7-7/8 hole to 5900' w/cut brine mud system, wt 9.1, vis 29-32. Test Yeso formation. Run 5-1/2 csg & cmt. Note: on production string, a caliper will be run, & COG will attempt to circulate cement.

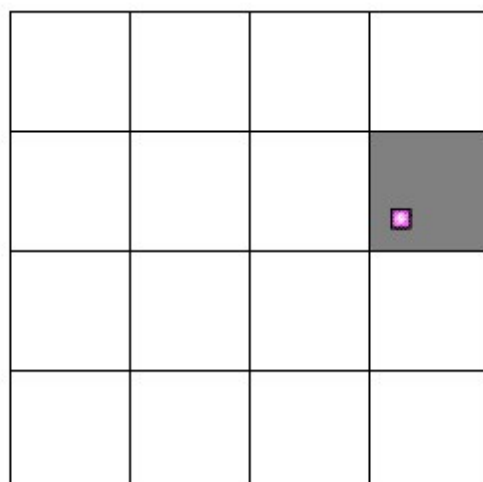
