Casing/Cement Program: Additional Comments

Plan to drill a 17-1/2" hole to 500' with brine. Run 13-3/8", 48#, J-55 csg and cmt to surface. Drill 12-1/4" hole to 2700' with fresh water, and run 9-5/8", 36# J55 and cement to surface in 2 stages. Drill 8-3/4" vertical pilot hole to 10,100'. Plug back with cement. Drill an 8-3/4" curve & lateral with cut brine to approx 11,925'MD. Run 5-1/2", 17#, P-110 csg and cement to 2,200'.
