For Multiple Completions: Attach wellbore diagram of proposed completion or recompletion. Spud well on 9/8/14. Set 8-5/8" csg at 922'. Had no returns so set DV tool. Cemented first stage: Lead 220 sxs Class C cmt (14.8 ppg). Second stage: Lead 280 sxs Class C, and Tail 150 sxs Class C. Contacted Randy Dade to get approval for top out (cement was showing at 120'). Got approval. Pumped 40 sxs; did not tag. Pumped another 40 sxs Class C and circ 10 sxs to surface. Test 8-5/8" csg to 2000 psi for 30 mins. Continue drilling. Reach TD at 4000' on 9/15/14. Run Triple Combo/Spec Gamma logs. Run 5-1/2" csg to 4000'. Cement with 125 sxs Lead 65/35/6 cement, and 235 sxs tail Class C cmt. Rig 9/6/2014 Spudded well.
