Casing/Cement Program: Additional Comments

COG proposes to drill a 17 1/2" hole to 350' 8.5 ppg, 28 vis fresh water mud system. Set 13 3/8" casing and cement to surface. Drill a 12 1/4" hole to 1350' with a 10 ppg, 30 viscosity brine water mud system. Set 9 5/8" casing and cement to surface. Drill an 8 3/4" hole to 3779' MD and kick off and drill an 8 3/4" curve to 4300' MD 4606' TVD. Drill an 8 3/4" lateral to new BHL at 4226' TVD 8873' MD. Run a tapered string with 7" 29# L-80 from surface to 3779' & 5 1/2" 17# L-80 casing to TD with and cement to surface.

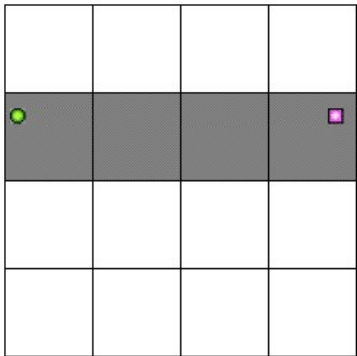
