Dear Mr. Stone:

Reference is made to your request on behalf of OWL SWD Operating, LLC ("operator") to extend the February 25, 2017 deadline stipulated in order SWD-1536 to commence drilling operations for the above referenced well for an additional one year for reasons outlined in the attached correspondence to the Mosaic Potash Company. The first extension was issued January 22, 2016, and extended the deadline to August 25, 2016. A second extension was issued August 6, 2016, and extended the deadline to February 25, 2017.

Paragraph nine of the administrative order contains a condition of approval that stipulates a deadline to spud the referenced well. This condition is the result of an agreement between the operator and the potash company with mineral interests at the well's location.

As required in the order, the Division has been provided confirmation by the Mosaic Potash Company that it has no objections to a one-year extension of the order for the referenced well.

Additionally, it is the Division's understanding from your request that there have been no significant changes in the information provided in the application submitted for review and approval of this order.

The Division finds that granting this request to extend this administrative order is in the interest of conservation, will prevent waste, and will protect the environment.

All requirements of the above referenced administrative order and agreements in the application remain in full force and effect excepting the deadline in which to commence drilling operations shall be <u>extended to February 25, 2018</u>. The deadline to commence injection operations remains May 19, 2017.

I hope all is well with you and 2017 is off to a good start.

We appreciate your previous extension for approval of the proposed location for the subject well in Section 6, T-23S, R-31E. As you know, this extension is due to expire on February 25, 2017 - just over two weeks from now.

Owl's management has asked me to relay their appreciation for your careful consideration of the fact that due to the current climate of the industry, we would again implore Mosaic to grant a one year extension, to be final.

The fact of the matter is that while this was a lengthy permitting process and involved numerous parties, no one at the time anticipated the duration or full impact of the industry slowdown. Things are obviously improving and Owl is now prepared to continue to move forward with projects that were suspended to adjust to market conditions. <u>Senior staff is confident that if this project is to be accomplished, it will happen in the next year</u>.

It appears from available reports and current GIS coverages that there has been no change in the area of review associated with the Section 6 location.

We therefore respectfully request that the availability of the location that Mosaic extend the location approval for one full year. This would coincide with the final expiration date of the OCD permit however; they are basing that extension on Mosaic's concurrent approval.
