Run 7-5/8" 29.7# HCP110 BTC casing to TD and cement to surface in one stage. Drill 6-3/4" vertical hole, curve & lateral to 18,805' with OBM. Run 5-1/2" 23# P110 BTC casing from 0' - 10,225' and 5" 18# HCP110 BTC from 10,225' to TD and cement to 10,225' in one stage.

pkautz	The operator shall keep a copy of the approved form C-101 and a copy of these conditions of approval at the well site.
