Plan to drill a 17-1/2" hole to 800' with fresh water. Run 13-3/8", 61# J-55 casing and cement to surface. Drill 12-1/4" hole to 5,210' with brine water, run 10-3/4" 45.5# HCL-80 casing and cement to surface. Drill 9-7/8" hole to 11,506' with cut brine, run 7-5/8" 29.7# HCP-110 casing and cement to surface. Drill 6-3/4" hole curve and lateral with 11 ppg OBM to approximately 22,196'. Run 4-1/2" x 5-1/2" tapered production string consisting of 4-1/2" 15.1# CYP-110 and 5-1/2" 23# CYP110 casing and cement to 8,000'.
