Drill 9-7/8" hole to 11,698' with cut brine, run 7-5/8" 29.7# HCP-110 casing and cement to surface. Drill 6-3/4" hole curve and lateral with 11.8 ppg OBM to approximately 22,387'. Run 4-1/2" x 5-1/2" tapered production string consisting of 4-1/2" 15.1# CYP-110 and 5-1/2" 23# CYP110 casing with cement to 8,000'.
