12/10/2020: Run 13.375 inch 54.5 lb J55 surface casing to 1045 ft. Pump 50 bbls gel w Ctb-15, 555 sks of 13.5 ppg lead cmt, 600 sks of 14.8 ppg tail cmt. Drop plug and displace with 150 bbls of brine. 180 bbls of cement returned to surface. Pressure test casing to 1500 psi for 20 minutes, good test.

Surface Casing Details: Casing ran: 12/10/2020, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1045 ft, Cement 1155 sacks, Yield 1.34, Class C, Pressure Held 1500 psi, Pres Drop 0.
