Cement with 715sx Lead 12.8ppg 35/65 POZ Class C + 3% CaCl2 + 6% Gel + 0.4% CPT-503P. 415sx tail 14.8ppg Class C neat cement. Lost pressure during displacement. Did not bump plug. Pumped a total of 151bbls displacement and 3bbls (half shoe track). Appears the casing parted at 730'. Further actions to be taken and Sundry's to follow once determination of well status and remediation are known.
