Conditions of Approval to Flare Gas

- 1. Approval not to exceed 365 days from date of submission.
- 2. All flaring under this request is considered "avoidably lost". Volumes for avoidably lost gas shall be reported on OGOR "B" reports as disposition code "33".

Exceptions:

- a. The first 24 hours of a temporary emergency flare is royalty free (NTL-4A III.A). Emergency flared volumes are not to be included in a Sundry Notice (Form 3160-5). These Volumes are not royalty bearing and shall be reported on OGOR "B" as either disposition code "21" or "22".
- b. If the operator believes that the flared volumes were an emergency under NTL-4A III.A and the flaring exceeded 24 hours, the operator can submit a request via Sundry Notice (Form 3160-5) with justification for an exception.
