Pressure test RBP to 550 psi while charting results

Verify leak location, isolate and establish rate and record in WellView

Report results to PE and confirm path forward.

Set 2nd RBP – depth to be confirmed during job. Test to 550.

Pulled rods out of hole. Pump was parted at the pull rod. Wireline perforated drain holes in tubing. Installed BOP. Pulled 10 stands and installed compression packer. Trip back in hole and set packer @ approximately 600'. Secure well.
