Pump 20 bbls chem water, 20 bbls visc water, followed by 1184 sks of 13.5 ppg lead cmt, 405 sks of 14.8 ppg tail cmt. Drop plug and displace with 397 bbls of freshwater. 104 bbls of cement back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
