5. Cement Sqz leak with ~ 100 sx of thixotropic cement blend following with 300 sx of class C cement w / 2% calcium chlorite
6. RIH with 4-3/4" bit and clean out to 4145, test sqz.
7. Continue Co to PBTD @ 4416' POOH with bit
8. RIH with injection equipment
9. Run MIT and place well back to services
