Actual Procedure: 2/21/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5340 ft. 2/23/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5331 ft. Pump 20 bbls chem water, 20 bbls visc water, followed by 1131 sks of 12.8 ppg lead cmt, 429 sks of 14.8 ppg tail cmt. Drop plug and displace with 401 bbls of freshwater. 110 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 2/24/2021: Drill 8.75 inch second intermediate hole to 11874 ft. 2/27/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11774 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 457 sks of 11.5 lead cmt, 149 sks of 13.2 ppg tail cmt. Drop plug and displace with 538 bbls of cut brine. Patrial returns of cement to surface. 20 bbls of spacer to surface. Pressure test casing to 2550 for 30 minutes, good test. First Intermediate Casing Details: Casing ran: 2/23/2021, Fluid Type Brine, Hole 12.25 inch, Csg Size 9.625 inch, Weight 40 lbs, Grade J55, Est TOC 0 ft, Depth set 5331 ft, Cement 1560 sacks, Yield 1.33, Class C, Pressure Held 1500 psi, Pres Drop 0.
