Actual Procedure: 3/1/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5350 ft. 3/4/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5333 ft. Pump 20 bbls chem water, 20 bbls visc water, followed by 1126 sks of 12.8 ppg lead cmt, 432 sks of 14.8 ppg tail cmt. Drop plug and displace with 401 bbls of freshwater. 65 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 3/5/2021: Drill 8.75 inch second intermediate hole to 11687 ft. 3/8/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11675 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 456 sks of 11.5 lead cmt, 149 sks of 13.2 ppg tail cmt. Drop plug and displace with 534 bbls of cut brine. 5 bbls of cement returned to surface. Pressure test casing to 2595 for 30 minutes, good test. First Intermediate Casing Details: Casing ran: 3/4/2021, Fluid Type Brine, Hole 12.25 inch, Csg Size 9.625 inch, Weight 40 lbs, Grade J55, Est TOC 0 ft, Depth set 5333 ft, Cement 1558 sacks, Yield 1.33, Class C, Pressure Held 1500 psi, Pres Drop 0.
