2/22/21 – NU BOP. POOH with tubing. Set a CIBP at 4019'. Pumped 15 bbls and pressured up to 1500 psi. Displaced well with 58 bbls brine mud gel and tested 4-1/2" casing to 500 psi, good. Spotted 25 sx Class "C" cement on top of CIBP to 3698' tagged.

2/23/21 – Perforated at 1955' and squeezed 45 sx Class "C" in/out cement plug and tagged TOC at 1782'. Perforated at 1250' and squeezed 50 sx Class "C" in/out cement plug and tagged TOC at 1050'.

2/24/21 – Perforated at 858' and squeezed 50 sx Class "C" in/out cement plug and tagged TOC at 670'. Perforated at 100' and squeezed 40 sx Class "C" cement down 4-1/2" and up 8-5/8" casing from 100' up to surface.

2/26/21 – Dug up cellar and cut off wellhead. Installed dry hole marker as per NMOCD. Covered cellar and cut off anchors.
