JOB PROCEDURES

1. Notify BLM / NMOCD at least 48 hours prior to conducting the bleed operation and again prior to conducting the MIT after the flowback operation is complete
2. Record current wellhead pressures, ND existing piping on casing valve
3. Install a flowback tank and flowback manifold on the casing valve
4. Open up the casing and bleed off pressure to the flowback tank for a duration of 1 week. Monitor tubing and casing pressure.
5. Shut in the casing and monitor the pressure build-up for a minimum of 24 hours. Report the beginning and ending pressures
6. Open up the casing and repeat the flowback and monitoring operation for an additional week.
7. Shut in the casing and monitor the pressure build-up for a minimum of 24 hours. Report the beginning and ending pressures
8. RU pump truck, pressure test surface equipment and wellhead to 1000 psi
9. Pressure test the casing to 650 psi, hold for 30 minutes and chart on a 2 hour chart. Monitor tbg and surface csg pressures during the test
10. Bleed off pressure, break out surface piping and RD pump truck. NU existing piping.

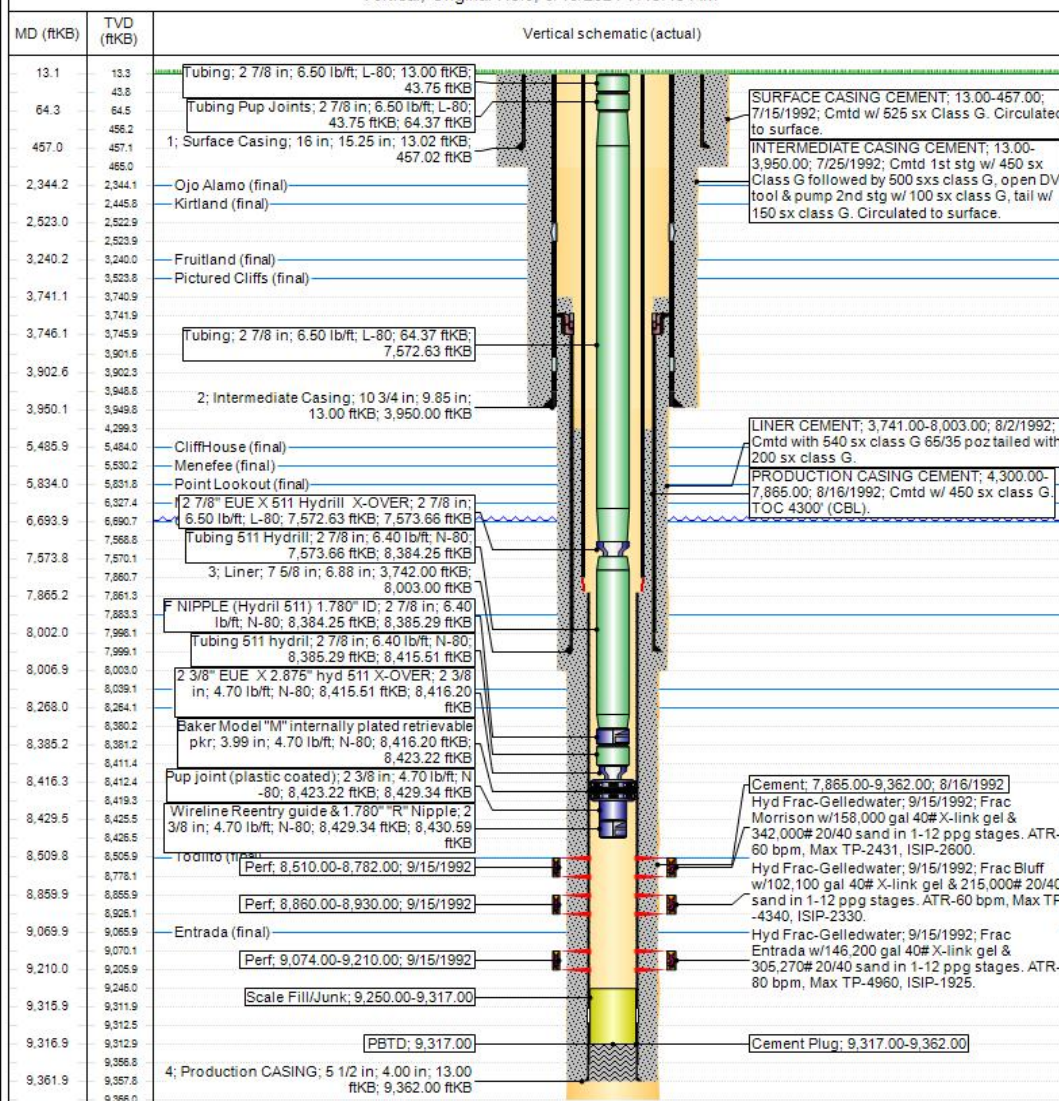
