Well was making a consistent 8-10 BOPD. Then it watered out. Foreman said it was due to COG's offset horizontals, but when COG completed those horizontals in 2014 nothing happened to production until a couple years later. On the Scharb well OCD reports a water flow in the Delaware formation. Where the rig encountered this is +/- where that well's casing leak was found. On the Guy Hooper either that flow has migrated over (NMOCD drilling reports shows nothing on this subject) to this well and has caused a casing leak or we have some communication from a nearby offset Wolfcamp disposal.

Plan of action on Guy Hooper is to POOH with rods & tbg & run a temp log to see if we have a possible casing leak, if we do, I think this well will probably fall into the P&A category. If we don't have a casing leak, its going to be hard to prove that a wolfcamp disposal affected this well, but there isn't much to do about it from a completion standpoint.

So the general plan is remedial work to identify if there is a wellbore issue & try to return well to production or P&A. There isn't anything uphole that looks to be economic.
