

## **GARRETT COM 100S - MIT**

### Job Procedure

- 1. Hold pre-job safety meeting. Verify cathodic is off. Comply with all NMOCD, BLM, and HEC safety and environmental regulations.
- 2. Check casing, tubing, and bradenhead pressures and record them in WellView. If there is pressure on the bradenhead, contact the Operations Engineer.
- 3. Remove existing piping on casing valve. RU blow lines from casing valves and begin blowing down the casing.
- 4. MIRU pump truck. Load casing w/ 2% KCL water and corrosion inhibitor.
- 5. Perform Mechanical Integrity Test (MIT) by pressure testing the 4.5" casing above the bridge plug set at 1,908' to 560 psig for 30 minutes on a 1-hour chart w/ a 1,000 lb spring.
- 6. If the test passes, shut in well, RD pump truck, and move off location. If test does not pass, contact the Operations Engineer to determine a plan of action.
