**Anemone ANE Federal 6 – Sub P&A**

3/23/21 – MIRU and NU BOP. Spotted a 34 sx Class H cement plug from 7514 ft – 7325 ft calc TOC. Notified Bob Hoskinson BLM-Carlsbad and will witness tag tomorrow.

3/24/21 – Tagged TOC 7352 ft. COA required 7333 ft. Bob Hoskinson gave verbal approval to proceed with next plug. Set a CIBP at 6743 ft. Pressure tested to 500 psi for 5 min, held good. Spotted 25 sx Class H cement on top of CIBP to 6606 ft calc TOC. No tag. Spotted a 25 sx Class C cement plug from 4408 ft – 4254 ft calc TOC. No tag. Spotted a 30 sx Class C cement plug from 2849 ft – 2665 ft, fill 184 ft. Additional 5 sx over 25 sx COA at request of Bob Hoskinson BLM Representative. Spotted a 25 sx Class C cement plug from 1878 ft – 1724 ft calc TOC, fill 154 ft.

3/25/21 – Tagged TOC 1755 ft. COA required 1735 ft. BLM did not approve this tag. Option given to pump 10 sx and WOC and tag or pump 25 sx and move on. Spotted an additional 25 sx cement on top of low tag. Calc TOC 1601 ft, no tag. Perforated at 110 ft. Squeezed 50 sx Class C cement from 110 ft up to surface. Topped off with cement.

4/7/21 - Cut off wellhead. Installed dry hole marker as per BLM. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
