Pump 40 bbls gel spacer, followed by 320 sks of 13.5 ppg lead cmt, 340 sks of 14.8 ppg tail cmt. Drop plug and displace with 97 bbls of brine. 90 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
