Actual Procedure: 4/4/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5303 ft. 4/6/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5288 ft. Pump 20 bbls chem wash, 20 bbls gel spacer, followed by 902 sks of 11.0 ppg lead cmt, 415 sks of 14.8 ppg tail cmt. Drop plug and displace with 399 bbls of freshwater. 170 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 4/8/2021: Drill 8.75 inch second intermediate hole to 11591 ft. 4/12/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11473 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 453 sks of 11.5 lead cmt, 121 sks of 13.2 ppg tail cmt. Drop plug and displace with 525 bbls of fresh water. 0 bbls of spacer returned to surface. Est TOC at 4175 ft. Pressure test casing to 2520 for 30 minutes, good test.
