Mixed @ 14.8#/g w/1.32 yd. Displaced w/180 bbls of FW. Plug down @ 10:30 P.M. 03/16/21. Circ 128 sks of cmt to the pit. Set Cameron mandrel hanger through BOP w/110k#.
