Actual Procedure: 4/12/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5300 ft. 4/14/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5279 ft. Pump 20 bbls chem water, 20 bbls visc water, followed by 984 sks of 11.0 ppg lead cmt, 353 sks of 14.8 ppg tail cmt. Drop plug and displace with 290 bbls of freshwater. 200 bbls of cement returned to surface. Pressure test casing to 1600 PSI for 30 minutes, good test. 4/15/2021: Drill 8.75 inch second intermediate hole to 11417 ft. 4/18/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11334 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 406 sks of 11.5 lead cmt, 141 sks of 13.2 ppg tail cmt. Drop plug and displace with 519 bbls of freshwater. Small amounts of spacer returned to surface. Pressure test casing to 2500 for 30 minutes, good test. First Intermediate Casing Details: Casing ran: 4/14/2021, Fluid Type Brine, Hole 12.25 inch, Csg Size 9.625 inch, Weight 40 lbs, Grade J55, Est TOC 0 ft, Depth set 5279 ft, Cement 1337 sacks, Yield 1.33, Class C, Pressure Held 1600 psi, Pres Drop 0.
