3/29/21 – MIRU and NU BOP. Set a CIBP at 2375'. Displaced well with 60 bbls brine mud gel. Tested 4-1/2" casing to 500 psi, good. Spotted 35 sx Class "C" cement on top of CIBP to 1868'.

3/30/21 – Tagged TOC 1790'. Perforated at 1018'. Tested to 500 psi, good. Spotted 35 sx Class "C" cement at 1074'. Tagged TOC 496'. Perforated at 408'. Attempted to establish rate through perf, held at 500 psi. Spotted a 30 sx Class "C" cement plug from 469' up to surface.

4/21/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
