4/12/21 - MIRU and NU BOP. RIH and tagged up at 7575 ft and spotted 35 sx Class C cement. Note: Spotted plug 49 ft high at 7575 ft due to fill. Adjustment made per BLM Representative Bob Hoskinson.

4/13/21 – Tagged TOC 7346 ft. Set a CIBP at 5786 ft. Circulated 235 bbls salt mud gel. Tested casing to 500 psi for 5 min, good. Spotted 55 sx Class C cement on top to 5446 ft. Displaced with 32 bbls brine mud gel. Spotted a 30 sx Class C cement plug from 3689 ft – 3514 ft. Displaced with 20 bbls brine mud gel. Spotted a 25 sx Class C cement plug from 2293 ft – 2144 ft. Displaced with 12 bbls brine mud gel.

4/14/21 – Perforated at 1232 ft. Spotted a 40 sx Class C cement plug from 1283 ft – 1042 ft, tagged. Displaced with 6 bbls brine mud gel. Spotted a 45 sx Class C cement plug from 844 ft – 694 ft. Displaced with 4 bbls brine mud gel. Perforated at 60 ft. Squeezed 50 sx Class C cement from 100 ft up to surface.

4/16/21 - Cut off wellhead. Installed dry hole marker as per BLM. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
