Pump 20 bbls chem wash, 20 bbls gel spacer, followed by 1125 sks of 12.8 ppg lead cmt, 453 sks of 14.8 ppg tail cmt. Drop plug and displace with 399 bbls of freshwater. EST TOC at 1040 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. BLM approved not to run remedial job. 5/4/2021: Drill 8.75 inch second intermediate hole to 11680 ft. 5/7/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11576 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 652 sks of 11.5 lead cmt, 138 sks of 13.2 ppg tail cmt. Drop plug and displace with 530 bbls of system fluid. Est TOC at 4157 ft.
