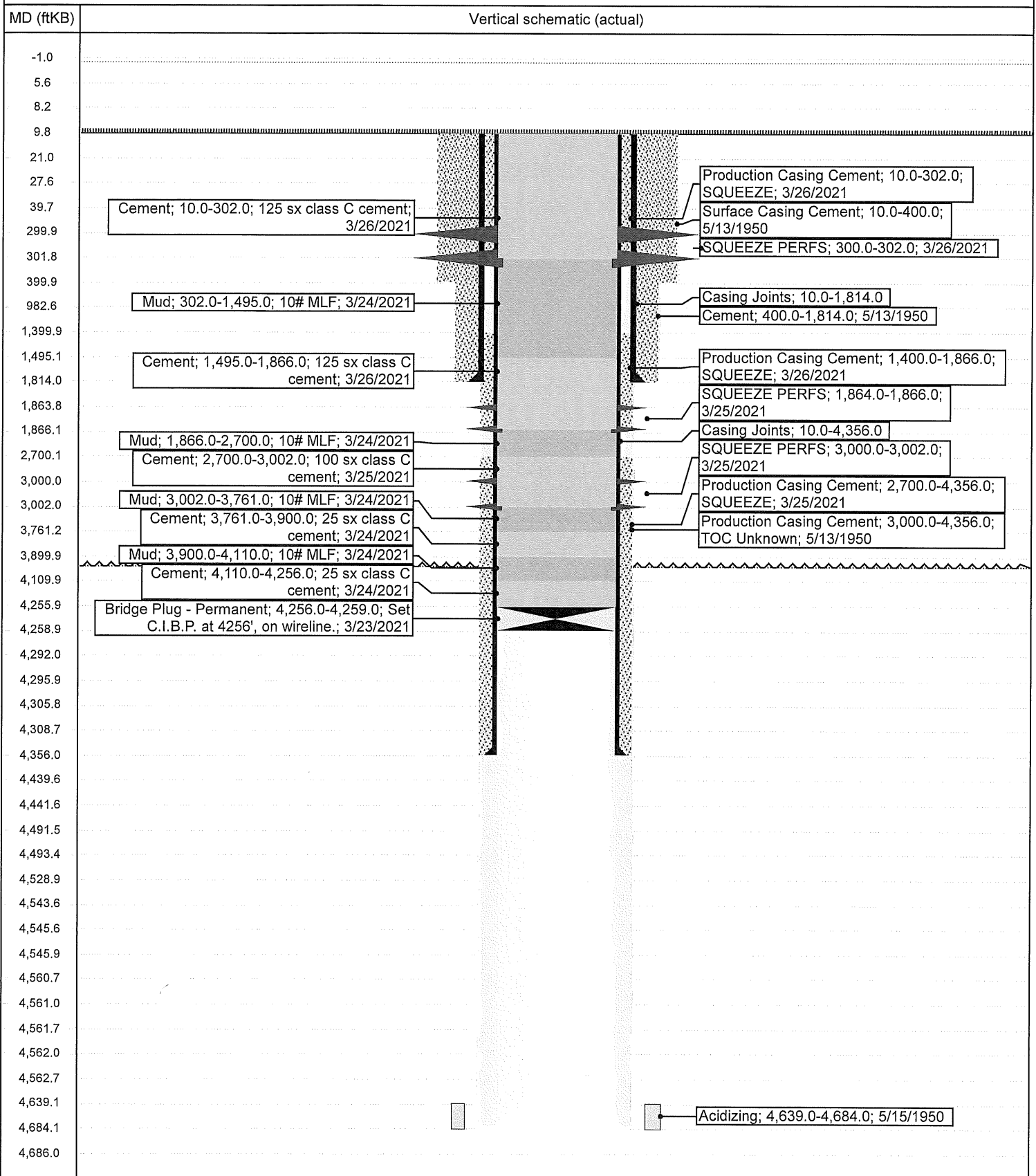
CURRENT SCHEMATIC
