4/21/21 – MIRU and NU BOP. Dropped 1.25" ceramic ball. Pumped 8 bbls and pressured up to 1500 psi. Set a CIBP at 2328'.  
 4/22/21 – Displaced 4-1/2" casing with 40 bbls brine mud gel and tested to 500 psi, good. Spotted 45 sx Class "C" cement on top of CIBP. Tagged TOC 1750'. Perforated at 1014'. Attempted to establish rate through perf, tested to 500 psi, good. Spotted 25 sx Class "C" cement at 1164'. Tagged TOC 805'. Perforated at 741'. Attempted to establish circulation through perf, tested to 500 psi. Attempted to spot plug 4 with 25 sx Class "C" cement.  
 4/23/21 – Perforated at 360'. Attempted to establish rate through perf. Tested to 500 psi, good. Spotted a 55 sx Class "C" cement plug from 791' up to surface. Received verbal permission from Gilbert Cordero NMOC-D-Artesia to cement perfs at 741' & 360' with a single plug if unable to establish rate through perfs.  
 4/30/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
