Pump 40 bbls gel spacer, followed by 560 sks of 13.5 ppg lead cmt, 290 sks of 14.8 ppg tail cmt. Drop plug and displace with 163 bbls of freshwater. 93 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
