Displaced w/149 bbls of BW. Plug down @ 8:15 A.M. 07/18/21. Circ 318 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 1:00 A.M. 07/19/21, tested csg to 1500# for 30 min, held OK. FIT to 10.5 PPG EMW. Drilled out at 12 ¼".
