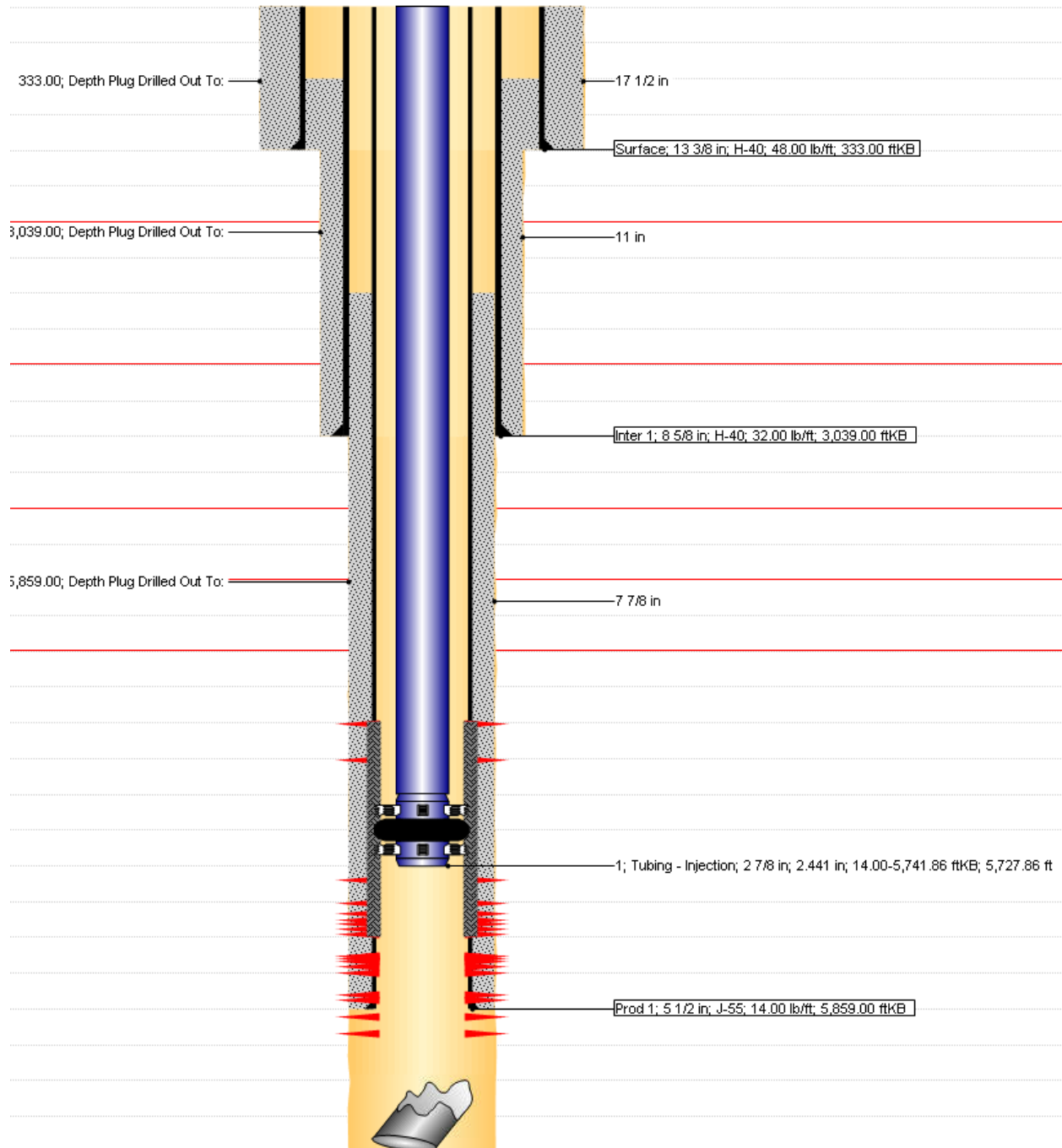

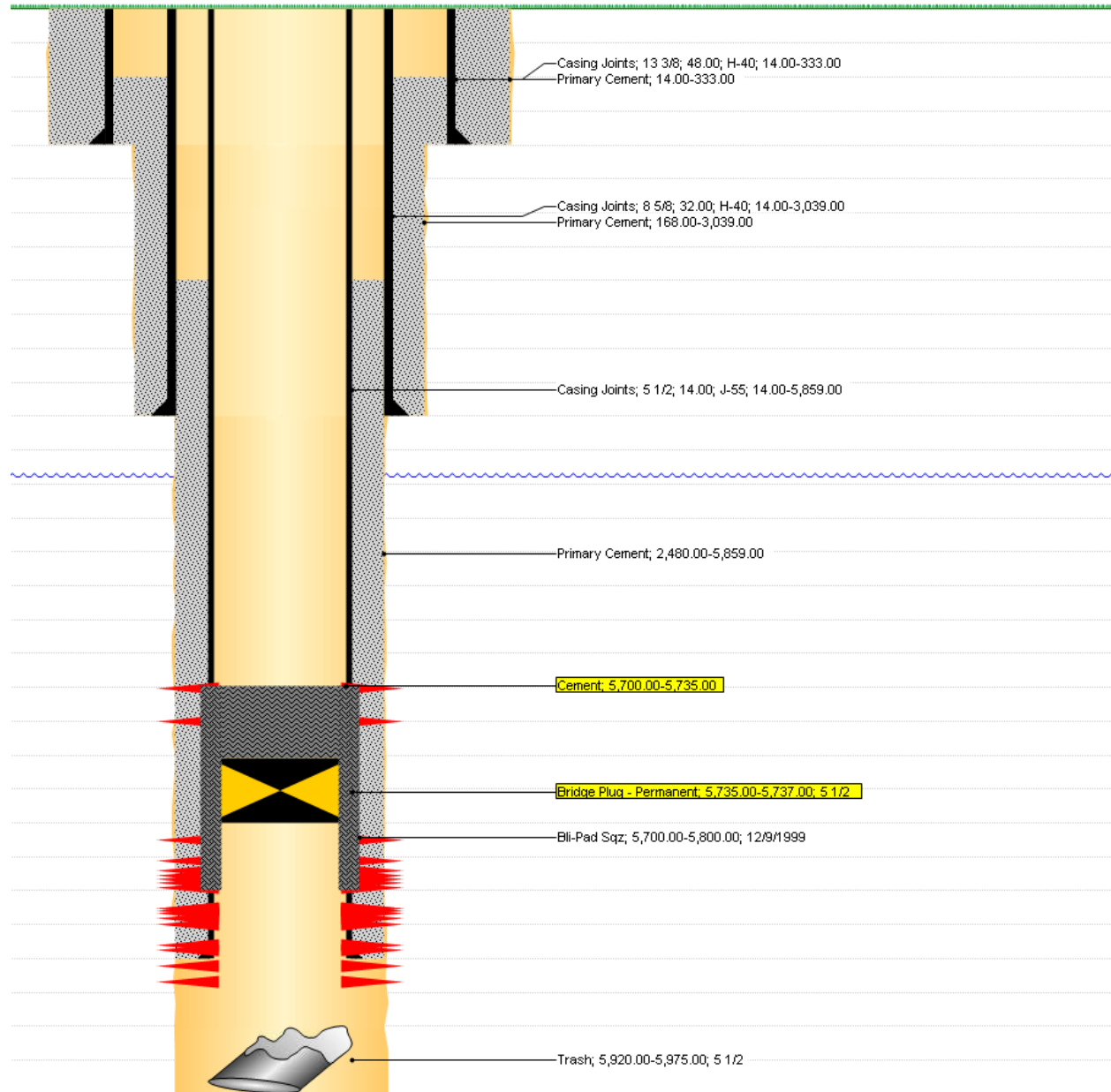
Vertical schematic (actual)

Vertical schematic (proposed)



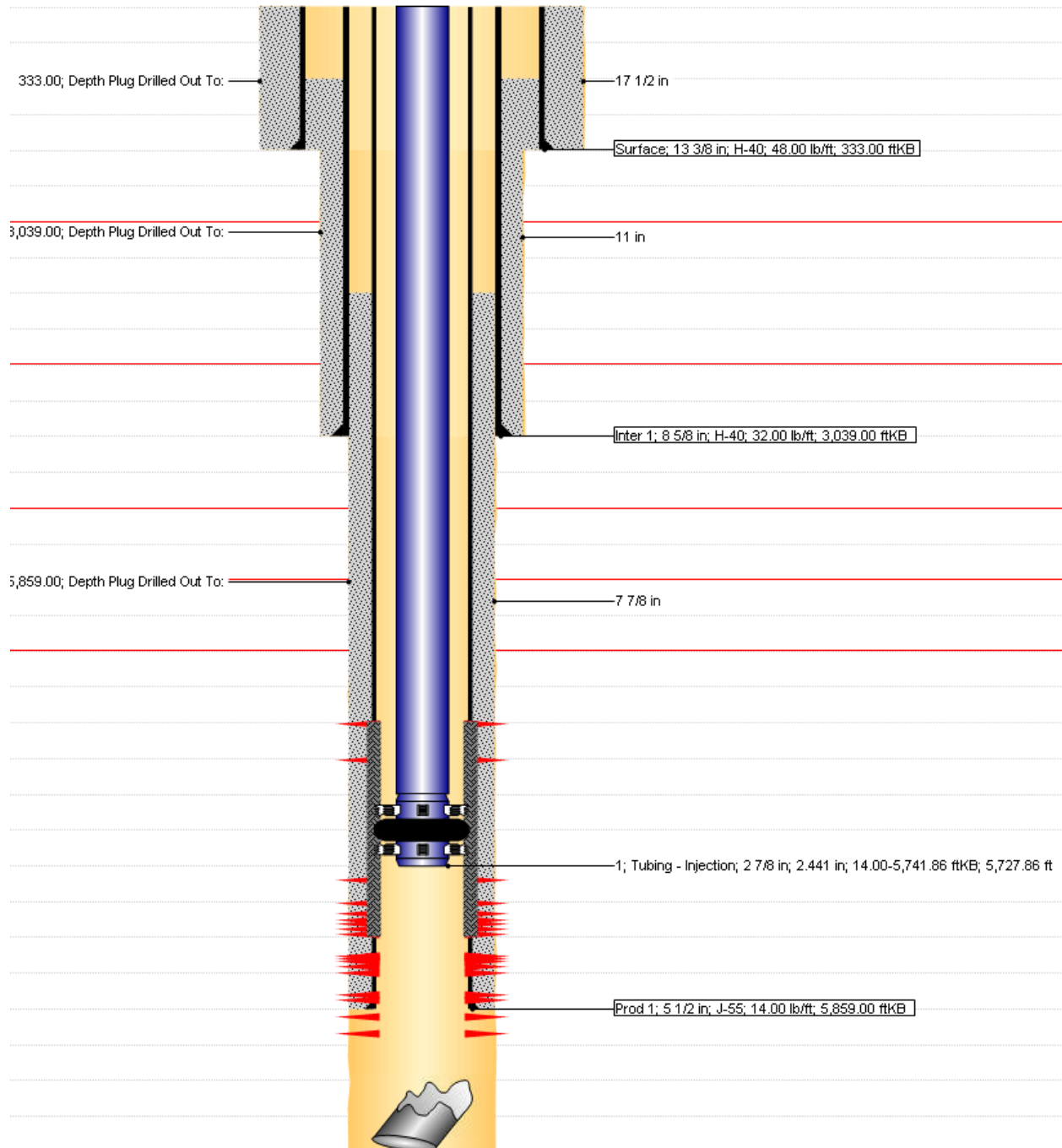

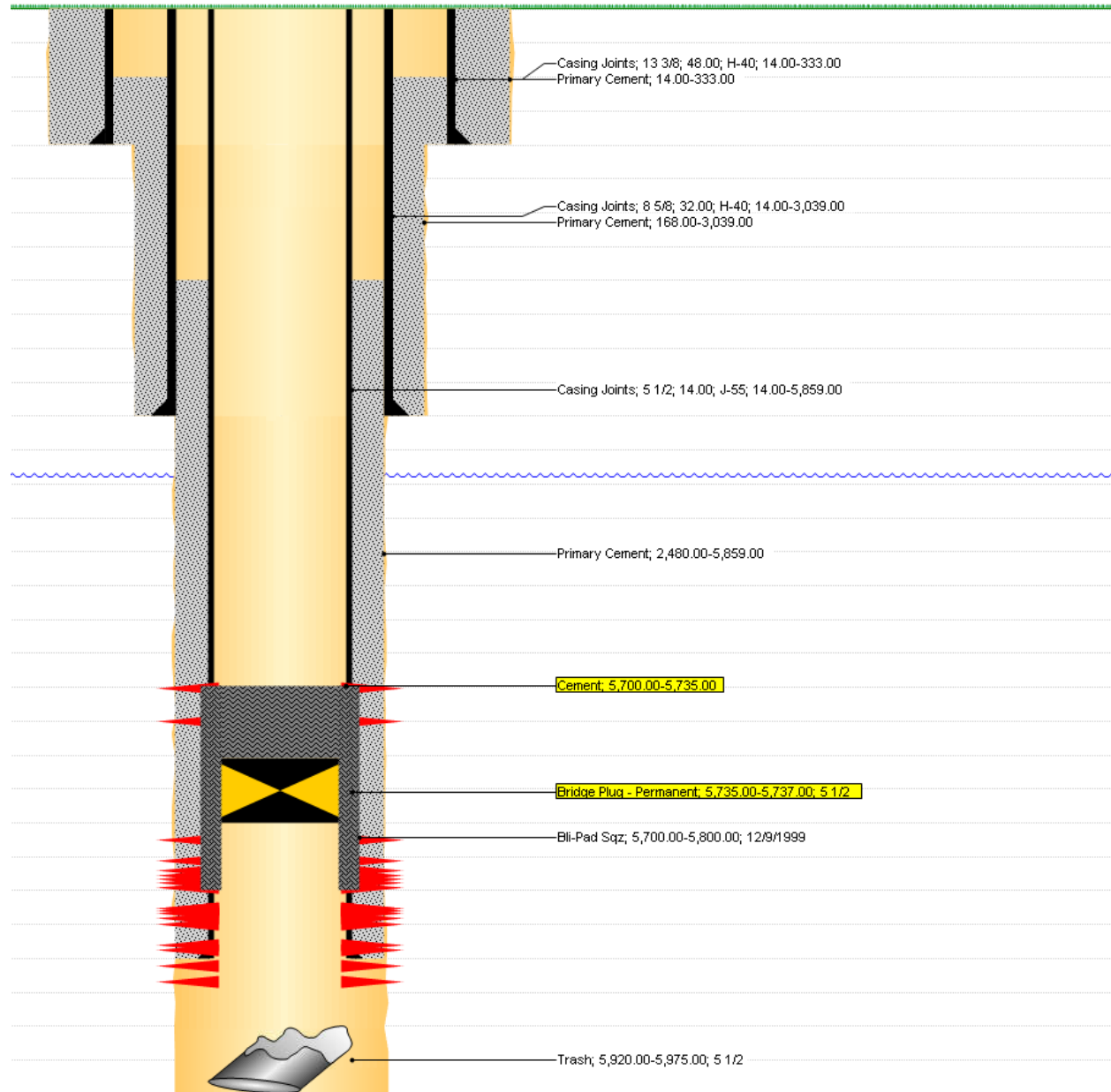
Vertical schematic (actual)
