**Actual Procedure:** 8/15/2021: Drill 17.5 inch surface hole to 1190 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1174 ft. Pump 40 bbls gel with CTB-15, followed by 560 sks of 13.5 ppg lead cmt, 290 sks of 14.8 ppg tail cmt. Drop plug and displace with 179 bbls of freshwater. 90 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/17/2021: Drill 12.25 inch intermediate hole to 3650 ft. 8/18/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 3637 ft. Pump 20 bbls chem water, 20 bbls visc water, followed by 790 sks of 12.8 ppg lead cmt, 376 sks of 14.8 ppg tail cmt. Drop plug and displace with 273 bbls of freshwater. 50 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/19/2021: Drill 8.75 inch second intermediate hole to 11314 ft. 8/22/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11230 ft. Pump 20 bbls visc water, followed by 896 sks of 11.5 lead cmt, 183 sks of 13.2 ppg tail cmt. Drop plug and displace with 513 bbls of freshwater. 0 bbls of cement to surface. EST TOC at 3750 ft. Pressure test casing to 1500 for 30 minutes, good test.
