Pump 40 bbls gel with CTB-15, followed by 585 sks of 13.5 ppg lead cmt, 290 sks of 14.8 ppg tail cmt. Drop plug and displace with 179 bbls of brine. 90 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
