Pump 40 bbls gel with CTB-15, followed by 785 sks of 13.5 ppg lead cmt, 345 sks of 14.8 ppg tail cmt. Drop plug and displace with 192 bbls of brine. 174 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
