Actual Procedure: 8/20/2021: Drill 17.5 inch surface hole to 1291 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1276 ft. Pump 40 bbls gel with CTB-15, followed by 785 sks of 13.5 ppg lead cmt, 345 sks of 14.8 ppg tail cmt. Drop plug and displace with 185 bbls of brine. 184 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
