Actual Procedure: 9/7/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5335 ft. 9/9/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5310 ft. Pump 20 bbls chem wash, 20 bbls gel spacer, followed by 928 sks of 11.0 ppg lead cmt, 357 sks of 14.8 ppg tail cmt. Drop plug and displace with 400 bbls of cut brine. 65 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 9/10/2021: Drill 8.75 inch second intermediate hole to 11222 ft. 9/13/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11120 ft. Pump 20 bbls chem wash, 20 bbls gelled water, followed by 282 sks of 10.5 lead cmt, 138 sks of 13.2 ppg tail cmt. Drop plug and displace with 508 bbls of cut brine. 30 bbls of spacer to surface. EST TOC at 1554 ft. Pressure test casing to 2500 for 30 minutes, good test. First Intermediate Casing Details: Casing ran: 9/9/2021, Fluid Type Brine, Hole 12.25 inch, Csg Size 9.625 inch, Weight 40 lbs, Grade J55, Est TOC 0 ft, Depth set 5310 ft, Cement 1285 sacks, Yield 1.33, Class C, Pressure Held 1500 psi, Pres Drop 0.
