Float collar @ 127'. Centralizers on joints 2 & 3. Cemented w/110 sks Type III (152 cu ft cement) w/1% CAC 12, 0.25 lb/sk celloflake, 0.2% C D-2 (14.6#/gal, 1.38 cu ft/sk, 6.6 gps Mix). Dropped plug. Displaced w/8 bbls water. Circulated 10 bbls cement to surface. Bumped plug. Plug on bottom @ 5:30 PM 9/30/2021. NMOCD witnessed job. WOC 10 hrs. RU Wilson Services for testing.
