Actual Procedure: 10/9/2021: Drill 17.5 inch surface hole to 667 ft. Run 13.375 inch 54.5 lb J55 surface casing to 652 ft. Pump 40 bbls gel spacer, followed by 360 sks of 13.5 ppg lead cmt, 260 sks of 14.8 ppg tail cmt. Drop plug and displace with 90 bbls of freshwater. 50 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 10/10/2021: Test BOPS. Drill 12.25 inch intermediate hole to 3085 ft. 10/12/2021: Run 9.625 inch 40 lb J55 intermediate casing to 3070 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 638 sks of 12.8 ppg lead cmt, 264 sks of 14.8 ppg tail cmt. Drop plug and displace with 229 bbls of freshwater. 68 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 10/9/2021, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 652 ft, Cement 620 sacks, Yield 1.33, Class C.
